## FOREWORD

The Government launched the Myanmar Sustainable Development Plan (MSDP) in August 2018. The MSDP recognizes the critical need for a coherent and consistent government-wide monitoring and evaluation framework as part of the implementation of the MSDP, to track and measure its effectiveness, efficiency, sustainability and impact on Myanmar's development and the well-being of our people.

The Central Statistical Organization (CSO), with the mandate to support the development of quality statistics for monitoring and evaluation of the MSDP and under the guidance of sustainable development principles, has developed the National Indicator Framework (NIF) to monitor progress against the MSDP's 28 strategies. Just as the MSDP is aligned with the SDGs, the NIF is also aligned with the SDGs by integrating SDG indicators into the framework across the 28 strategies of the MSDP.

The NIF itself has two key objectives: to serve as an indicator framework to monitor progress against the MSDP and to support the strengthening of National Statistical System. Therefore, NIF is not only a tool for the monitoring and evaluation of the MSDP, but also an important mechanism for strengthening the coordination among statistics units of departments and organizations, and for improving the quality of official statistics. To support the strengthening of the National Statistical System, we will implement the NIF in conjunction with the action plans for the National Strategy for the Development of Statistics (NSDS).

I commend the CSO for its tireless work to develop and finalize the NIF, and express my gratitude to the UNDP for providing technical assistance during its development. I would also like to express my sincere appreciation to the Government Departments, UN agencies, Development Partners, NGOs, Civil Society Organizations and Private Sector Organizations who provided technical support throughout the development process of the NIF.

Finally, I look forward to the successful implementation of the NIF and further improved coordination among the ministries and departments for producing quality statistics in support of the monitoring and evaluation of the MSDP.

## I. INTRODUCTION

The Myanmar Sustainable Development Plan (MSDP) was launched in August 2018. The MSDP is structured into 3 Pillars, 5 Goals, 28 Strategies and 251 Action Plans. The MSDP aims to provide a “long-term vision (2030) of a peaceful, prosperous and democratic country and is founded upon the objective of giving coherence to the policies and institutions necessary to achieve genuine, inclusive and transformational economic growth”.<sup>1</sup> The MSDP also emphasizes mainstreaming key principles of sustainable development across all its strategies and action plans, i.e. (1) Social Inclusion; (2) Sustainability in all its forms; (3) Conflict Sensitive Approach; and (4) Democratic Principles.

The MSDP document insists on the critical need for a coherent and consistent government-wide monitoring and evaluation (M&E) framework in the implementation of the MSDP to track and measure its effectiveness, efficiency, sustainability and impact throughout and following the planned implementation period of 12 years.

The MSDP describes an implementation mechanism overseen by the MSDP Implementation Unit.

The M&E Framework is composed of two main elements:

- (1) The National Indicator Framework (NIF), comprising 281 indicators, all with metadata and a baseline where available. Targets are yet to be set for these indicators.
- (2) A Monitoring & Evaluation System, or set of
- (3) institutional arrangements, detailing the roles and responsibilities of different government agencies in implementing the M&E strategy, the flows of information between these agencies and the reporting modalities to higher-level.

The MSDP is monitored at two levels (see figure-1 below):

- *Action Plan level*, tracking inputs, processes (activities) and outputs of the government’s projects and programmes under the different MSDP Action Plans, including infrastructure projects selected through **the Project Bank**.
- *Strategy & Goal level*, tracking outcomes and impacts of the combined implementation of different MSDP action plans on Myanmar’s sustainable development.

**Input Indicator:** measures the financial and non-financial resources invested into a project.

**Process Indicator:** describes the activities implemented and the structures and institutional arrangements within which they occur.

**Output Indicator:** describes the products, capital goods and services, capacity gains, which result from a project.

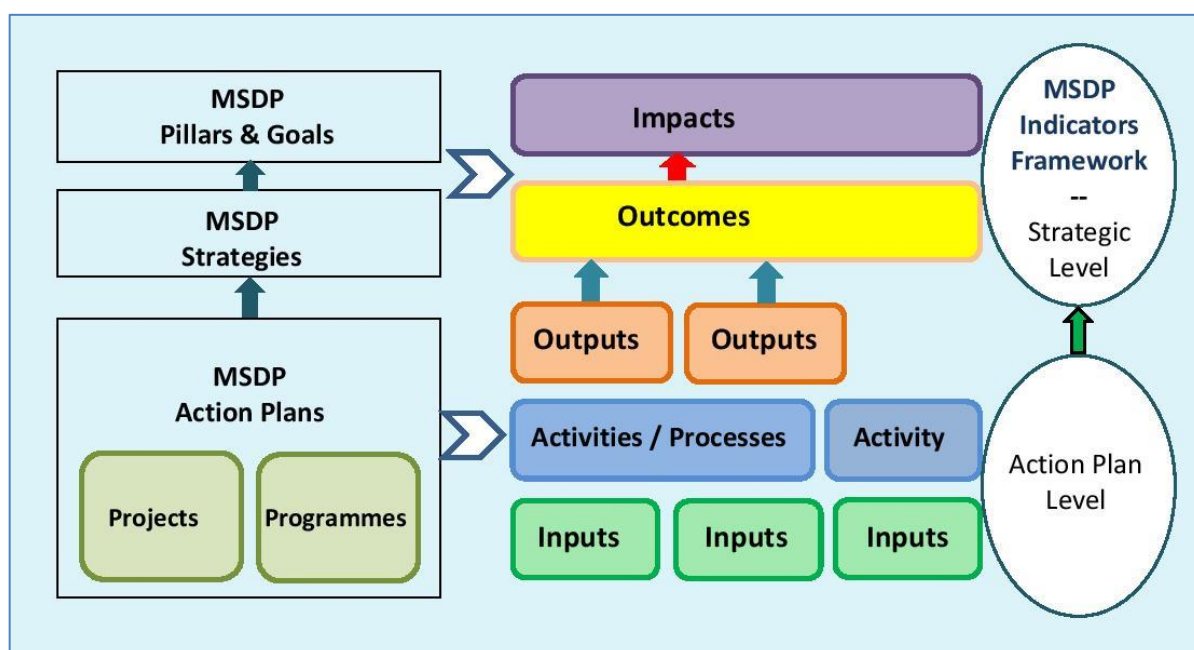
**Outcome Indicator:** describes a higher-level change in conditions and capacities to which achieved outputs are meant to contribute.

**Impact Indicator:** describes the changes, negative or positive, in people’s lives and in the country’s overall development conditions

## **II. PRINCIPLES FOR DEVELOPING THE NIF**

A comprehensive set of principles was applied to guide the development process of the NIF:

- NIF Indicators use available data in Myanmar that fits **globally-accepted quality criteria** for statistical activities.<sup>2</sup>
- The NIF focuses on the **key areas of change** pursued by each MSDP Strategy, rather than trying to cover all aspects of all Action Plans under each strategy.
- The set of indicators selected for each MSDP strategy allows capturing properly three **cross-cutting sustainable development dimensions** prioritized by the MSDP (social inclusion, environmental sustainability and conflict sensitivity). The scoring system used to evaluate the level of the mainstreaming of cross-cutting sustainable development dimensions into selected indicators can be found in ANNEX.
- Global Sustainable Development Goals (SDGs) indicators are adopted** wherever relevant to monitor against the strategies of the MSDP.
- To guarantee that monitoring on the MSDP starts delivering tangible results rapidly, **the majority of selected MSDP indicators are already measurable**.
- The NIF offers an opportunity to **modernize development data monitoring in Myanmar**: if a particular indicator has not been used before in Myanmar but has been proven in other contexts to effectively capture progress towards sustainable development, then it has been adopted, while the Government, with the help of development partners, has committed to mobilize the technical and administrative solutions necessary to measure it.
- The NIF identifies **indicators that are simple to understand** by the wider public, in order to reinforce national ownership of the MSDP and allow social accountability over the implementation of the MSDP.
- The NIF includes **perception and qualitative indicators** to reflect the views of the main beneficiaries of the MSDP (including all vulnerable or marginalized groups, civil servants, civil society, and private businesses) on the development progress achieved in their country.

### III. DESIGN OF THE MSDP-NIF

The design of the NIF took place in three phases including a series of consultative meetings from mid-2018 to mid-2019.

#### PHASE 1

In **July 2018**, based on a previous mapping conducted by the Myanmar Development Institute (MDI), the development of the NIF started with a thorough mapping of existing indicators measured in Myanmar. The mapping of the indicators came both from relevant national sectoral strategies/plans and from Myanmar's

2017 [SDG Indicator Baseline Report](#). Indicators were mapped against the 28 MSDP Strategies according to their thematic relevance, and then analysed by using the following criteria: focus level (input, process, output, outcome or impact indicator), measurement readiness and coverage of cross-cutting themes (social inclusion, environmental sustainability and conflict sensitivity). As a result, 277 indicators relevant to the MSDP were identified through the mapping exercise.<sup>3</sup>

In **August 2018**, a kick-off workshop was conducted for a large number of government departments, development partners and civil society organizations. The results of the mapping exercise were presented at the workshop. During this workshop, 13 Task Teams were established, in line with the thematic areas covered by the MSDP (see table-1 below). These Task Teams were tasked to finalize the list of indicators for each MSDP Strategy, including from those identified through the mapping process and to formulate new indicators.

#### PHASE 2

A first round of Task Team meetings was held in **August 2018** (with 133 government agencies, 12 development partners and 7 civil society or private sector organizations) and resulted in the Draft Zero of the NIF.

A second round of Task Team meetings took place in **December 2018** (with 129 government agencies, 14 development partners and 5 civil society or private sector organizations), to review and improve Draft Zero. As a result, a second draft of the NIF (Draft One) was released in March 2019 and sent to all Task Team members for comments, as well as to all development partners in Myanmar (through the Cooperation Partners Group) and to the NGO community (through the INGO Forum and the Local Resource Center).

### PHASE 3

In **June 2019**, a third and final round of Task Team consultations was organized (with 135 government agencies, 19 development partners and 7 civil society or private sector organizations) to review the 295 comments received<sup>4</sup> on the NIF Draft One and amend it where relevant. The Final Draft of the NIF was released in July 2019 as a result.

### IV. RESULT: OVERALL ANALYSIS OF THE MSDP-NIF

The NIF has the following characteristics:

- **Size:** 281 indicators, with an average of 10.04 indicators per Strategy (minimum of 5 and maximum of 14).
- **Level:** 70% of the indicators focus on the Strategy/Goal level while 30% on the Action Plan level.
- **SDGs:** 41% of the NIF indicators are also SDG indicators. The highest rate of SDG indicators is found in Strategy 4.1 (Improve equitable access to high quality lifelong educational opportunities), with 91% while strategy 2.2 (Reduce inflation and maintain monetary stability) has the lowest rate of SDG indicators, with 11%.
- **Frequency:** nearly three-quarters (70%) of indicators can be measured annually while 6% will be measured every 2 years, and the rest (24%) need to be measured through wide-scale surveys that usually take place every 3-5 years.
- **Cross-cutting dimensions:** using a marker system, '0' means an indicator that has no link at all with the dimension, and '2' means the highest degree of linking;<sup>5</sup> the table shows how the 281 indicators of the NIF stand:

During the NIF development process, **indicator focal points** within data producing agencies were identified. They are responsible for data gathering, first-level quality control and timely reporting within their departments or organizations. Data collection includes receiving and compiling data from Region/State or township level units within their own organizations. Indicator focal points report data according to a set timetable and format to the Central Statistical Organization (CSO). The CSO is then responsible for a second, and deeper, quality control process.

Over half of the MSDP-NIF indicators had a pre-existing **baseline** at the time of finalizing the framework. Yet, many were also dating back more than 3-4 years. The first reporting exercise on the NIF will be the occasion to establish a fresh set of baselines for all the measurable indicators that will be reported at that time. End-period (2030) targets for all indicators have yet to be established where it is relevant to do so,

and if possible, intermediary targets as well. Baselines and targets are required to build an informed analysis of the country's performance in reaching the objectives set forth by the MSDP.

## **V. INSTITUTIONAL ARRANGEMENTS FOR MONITORING THE NIF**

In order to support the monitoring of the MSDP implementation, MSDP-NIF Monitoring System has been designed to produce evidence-based NIF reports every year. On the monitoring side, it clarifies the roles of a number of Ministerial departments as data producers, and the CSO and the Planning Department.

Annually, two reports will be produced:

- The **MSDP Status Report**
- The **NIF Status Report**

The annual NIF monitoring and reporting cycle is as follows:

### 1) Indicator Reporting and Quality Control

Indicator focal points in government agencies submit indicator reports to the CSO. These reports consist of the latest indicator values and short narratives interpreting reported trends. These reports are then reviewed by the CSO against the quality criteria set forth in each indicator's metadata. Further details on specific indicators may be requested from concerned agencies if needed.

Based on indicator reports, the CSO prepares for the Planning Department a consolidated NIF Status Report with quality-checked data for each indicator and a basic trend analysis.

### 2) Strategic Analysis

Drawing on its expertise in cross-sectoral planning, the Planning Department summarizes and interprets the values and narrative updates of the 281 NIF indicators into progress reports for each of the 28 MSDP strategies and for the 5 MSDP goals. These progress reports will be consolidated into the MSDP Status Report.

### 3) Data Quality Upgrade

The report produced by the CSO will contribute to issue guidance to governmental agencies for improving data collection, data accuracy and indicator computation, so as to produce with each passing year a more accurate and comprehensive MSDP Status Report. The National Strategy for the Development of Statistics (NSDS) Clusters are mobilized to support implementing policy decisions to reach higher quality of NIF reporting.
